



## START ACTION NOTICE # 2019-02

1. TYPE OF ACTION:

The adoption of amendments to 7 DE Admin. Code 1302, Delaware's *Regulations Governing Hazardous Waste* (DRGHW)

2. PURPOSE OF ACTION:

The purpose of this action is to adopt federal regulatory amendments required to maintain a delegated, authorized program. The planned revisions include adopting the following federal rules:

- (1) Imports and Exports of Hazardous Waste – Checklist 236
- (2) Hazardous Waste Generator Improvements Rule – Checklist 237
- (3) Confidentiality Determinations for Hazardous Waste Export and Import Documents – Checklist 238
- (4) Hazardous Waste Electronic Manifest User Fee Rule – Checklist 239
- (5) Safe Management of Recalled Airbags – Checklist 240
- (6) Management Standards for Hazardous Waste Pharmaceuticals and Amendment to the P075 Listing for Nicotine

3. STATUTORY BASIS:

Amendments to Delaware's hazardous waste regulations are proposed and amended in accordance with the provisions found at 7 *Del. C.* §§ 6010(a) and 6305.




