RAC and Environmental Comments

I have had a very amiable and valued relationships with everyone from DNREC !

I sent in my applications stating my concerns were environmental and the need for border monitors. I was honored to be selected to the RAC. My concerns were that Claymont has never had any permanent monitors. The closest one is located 5 miles south of Claymont in Bellevue Park measuring only for Ozone & SO2. Sadly this problem was never addressed at the RAC, meetings even though I brought it up.

All of the RAC meetings were open to the public with comment periods open after the meeting to those attending/online. There were no time limits set on the comments until Bill Dunn's comments were considered too lengthy and detailed, which we all needed to hear, when comments were cut to 3 minutes. Bill Dunn had applied and wasn't selected for the RAC, while I was selected with nothing to offer except for the success of the Claymont Dust Study Team.
