

DNREC extends public comment period through Dec. 31 for Walan Specialty Construction Products, LLC's Delaware air quality regulations construction permit

On Oct. 19, DNREC received a Regulation No. 1102 Natural Minor Construction Permit Application submitted by Walan Specialty Construction Products, LLC to construct a slag grinding, drying, and processing facility at the company's proposed location for the facility at 501 Christiana Avenue in Wilmington.
