1. Set-up hours -7:30 am to 9:30 am October 19, 2019 (all vehicles must be out of exhibitor area and parked in parking lot by 9:30 am)
2. The Festival is officially open to the public from 10:00 am to 4:00 pm on October 19, 2019. You must wait until 4:00 pm to take your display down.
3. Spaces allotted are 10' x 10' for artisan and educational exhibitors and food vendors are 15' x 25'. **If you are concerned that this won't be enough space for you please contact the festival organizers.**
4. **YOU MUST PROVIDE YOUR OWN TABLE, CHAIRS, TENT, and ELECTRICITY.**
If you need electricity you will need to bring a generator.
5. Booth assignment is at the sole discretion of the Delaware National Estuarine Research Reserve.
6. "No Shows" will not be invited back the following year.
7. The Blackbird Creek Festival Committee reserves the right to prohibit the sale or display of certain products/distribution of materials based on its acceptability to the general public.
8. Space is limited. When registration is filled, festival organizers will place you on a wait list. If space becomes available, additional participants will be invited in order of registration.
9. All craft work must be original—conceived, designed, and executed by the exhibiting artist.
10. **Artisan and food vendor spaces are \$25, payable by check made out to the "State of Delaware". Refunds will not be granted after participation in the Blackbird Creek Fall Festival is confirmed. There is no charge for non-profit informational exhibitors.**
11. **No alcoholic beverages or smoking permitted on festival grounds.**
12. This is a rain or shine event.
