

# **Instruction for use of “Annual Notification of Changes Report” Form**

(Applicable to all paint stripping operations)

## **General**

This form may be used to comply with the annual reporting requirements in 13.6.1 of Regulation 1138. The use of this form is optional. However, other means of reporting changes must be prepared according to the applicable requirements under 13.6.2 and 13.6.3 of Regulation 1138.

This “Annual Notification of Changes Report” form may be used to identify all deviations that occurred during the reporting period. If more than five (5) deviations occurred, the owner or operator should use and attach additional sheet (provided) to the “Annual Notification of Changes Report”.

If no deviations occurred during the reporting year, the owner or operator of the affected paint stripping operation does not need to submit an “Annual Notification of Changes Report.”

## **Required Submittal Date**

If a deviation occurred during the reporting year, the owner or operator shall complete and submit the “Annual Notification of Changes Report” to the Department (with copy to the U.S Environmental Protection Agency) prior to March 1 of the year following the reporting period.

The addresses for these submittals are provided below and in Item 6 of the “Annual Notification of Changes” form.

## **Items 1 and 2**

Provide the name of the affected paint stripping operation, its physical location, and the address where compliance records are kept, if different than the physical location of the facility.

## **Items 3**

Identify the owner or operator of the affected paint stripping operation, identified in Items 1 and 2.

## **Item 4**

The owner or operator of the affected paint stripping operation shall list all deviations that occurred at the facility during the reporting period. The owner or operator shall provide the following information for each deviation:

- The date the deviation occurred,
- The affected source in which the deviation occurred,
- A brief description of the deviation, and
- The corrective actions taken to bring the affected source back into compliance with Section 13 of Regulation 1138.

If more than the five (5) deviations (allowed for on Page 1 of this form) occur, the owner or operator should use multiple copies of additional sheet (provided) and attach these additional pages to the “Annual Notification of Changes Report” form.

## **Item 5a**

Requirement 13.4 of Regulation 1138 provides the requirements that the owner or operator of an affected paint stripping operation must be in compliance with to satisfactorily demonstrate compliance with Section 13 of Regulation 1138.

For this form, the owner or operator would certify compliance with Section 13 of Regulation 1138 by checking the appropriate boxes listed under Item 5a.

If the owner or operator of the affected paint stripping operation is unable to certify that the paint stripping operations are in compliance with the applicable requirements of Section 13 of Regulation 1138 at the time of submitting the “Annual Notification of Changes Report”, the owner would not check the first and/or second box under Item 5a, whichever is applicable. Instead, the owner or operator completes Item 5b.

## **Item 5b**

If the affected paint stripping operations are not in compliance with the applicable requirements of Section 13 of Regulation 1138, the owner or operator must provide a complete explanation of the noncompliance, the corrective actions being undertaken to bring the paint stripping operations back into compliance and the expected date that compliance will be demonstrated. Space for this information is provided on page 2 of the form. The owner or operator should continue on additional sheet (provided), if additional space is needed.

## **Item 5c**

The owner or operator of the affected paint stripping operation certifies that the “Annual Notification of Changes Report” is true, accurate, and complete as demonstrated by the completion of Item 5d.

## **Item 5d**

The owner or operator of the affected paint stripping operation provides the information needed and signs the form to certify the truth, accuracy, and completeness of the “Annual Notification of Changes Report”.

## **Item 6**

The owner or operator must submit the completed “Annual Notification of Changes Report” to the Department of Natural Resources and Environmental Control (with a copy to the U.S. Environmental Protection Agency) at the addresses provided below and in Item 6 of the form. The owner or operator should keep a copy of the completed form.
