#### **LEGAL NOTICE - PUBLIC HEARINGS**

The Department of Natural Resources and Environmental Control (DNREC) will conduct four public hearings on proposed revisions to Delaware air regulations and Delaware's State Implementation Plan (SIP). The hearings will address:

- Repeal of 7 DE Admin. Code 1123 regarding Standards of Performance for Steel Plants: Electric Arc Furnaces.
- Amendment to 7 DE Admin. Code 1136 to update of the federal reference date in regards to the Acid Rain Program.
- Amendments to 7 DE Admin. Code 1140 to update the adoption by reference of California's Low Emission Vehicle (LEV) III and the Greenhouse Gas (GHG) standards.
- SIP revisions: 1) certification that the Delaware Emission Statement program and the Preconstruction Review program meet all 2008 Ozone NAAQS requirements, and 2) a negative declaration that the state of Delaware has no sources covered by EPA's 2016 Oil and Gas Control Techniques Guidelines.

The hearings will be held on Wednesday, **October 25**, beginning at 6:00 PM at the DNREC Auditorium, located at the Richardson & Robbins Building, 89 Kings Highway, Dover, DE. The four separate hearings will be held in succession, in the order shown above, beginning at 6:00PM. Persons interested in one or more of the hearings should arrive by 6:00PM, as these changes are expected to be non-controversial and the hearings may progress quickly. The proposed revisions are available for public review at the Department's offices at 715 Grantham Lane, New Castle, DE and 100 West Water Street, Suite 6A, Dover, DE. **WHS - SITE INVESTIGATION AND RESTORATION SECTION (SIRS)** is responsible for the identification, evaluation, and remediation of sites in Delaware that have had past releases of hazardous substances. The section manages the contaminated sites under three major programs in accordance with the Hazardous Substance Cleanup Act (HSCA). The three programs are the **Brownfields Development Program, the Voluntary Cleanup Program (VCP), and the HSCA Enforcement Program** (for sites requiring enforcement action).

**LEGAL NOTICE NOTIFICATION OF NEGOTIATIONS CONCERNING A VOLUNTARY AGREEMENT FOR THE 2002-2012 WEST NEWPORT PIKE SITE (DE-1665)**

Pursuant to the June 2000 amendment to the Hazardous Substance Cleanup Act (HSCA), 7 Del. C. § 9107 (a)(1), the Department of Natural Resources and Environmental Control (DNREC) is required to issue a public notice announcing the onset of negotiations concerning Voluntary Cleanup Program (VCP) Agreements, as well as any voluntary settlement agreements requiring a remedy, between DNREC and potentially responsible parties. The amendment states that DNREC must provide “public notification within 20 days after entering into negotiations for a voluntary cleanup settlement agreement with any person that agrees to perform a remedy.” The Site Investigation and Restoration Section (SIRS), on behalf of DNREC, initiated the VCP in February 1995 in an effort to lessen the time and cost required in cleaning up contaminated sites by reducing litigation. VCP Agreements are available, upon application to DNREC, to potentially responsible parties or prospective purchasers who may be liable for the contamination of a property, but who wish to settle their liabilities with DNREC under HSCA. DNREC is negotiating a VCP Agreement with Delmar Realty Company regarding the 2002-2012 West Newport Pike, Wilmington Site (Site) located at 2002-2012 West Newport Pike in Wilmington. The approximate 3.66 acre Site is identified on the maps of New Castle County as tax parcel number 07-046.10-161. The Site may have had a release of hazardous substances as a result of past use as a dry cleaning facility and from a formerly leaking underground storage tank. **The Brownfields Development Program** encourages the cleanup and redevelopment of vacant, abandoned, or underutilized properties, which may be contaminated. A party seeking to develop such a property negotiates with SIRS for a **Brownfields Development Agreement (BDA)** to perform an investigation and, if necessary, a remedial action or remedy, for the purpose of addressing the risks posed by past releases of hazardous substances at these sites. However, a BDA is only available to parties that are not current site owners. The **Voluntary Cleanup Program (VCP) Agreement** is available to site owners who want to clean up their sites and are already liable as a potentially responsible party for the site.

The Department of Natural Resources and Environmental Control (DNREC), Division of Water Resources, Surface Water Discharges Section and the Department of Agriculture, Nutrient Management Program ,hereby give notice that the following farms have applied for coverage

under National Pollutant Discharge Elimination System (NPDES) General Concentrated Animal Feeding Operation (CAFO) Permit Number DE 5000N/11, to operate a Large, Medium, or Designated Poultry CAFO without land application of manure under Section 9.5 of the DNREC's Regulations Governing the Control of Water Pollution. Large CAFO's are characterized as having equal to or greater than 125,000 chickens (C), 82,000 laying hens (L), or 55,000 turkeys (T). Medium CAFO's are characterized as having 37,500-124,999 chickens, 25,000-81,999 laying hens, or 16,500-54,999 turkeys. Designated CAFO's are determined by the department and can be any size. Chicken manure is not land applied by these farms and is exported off the farm. Manure is stored and mortalities are handled in a manner to prevent contamination of waters of the state. All farms have Animal Waste Management Plans that meet the criteria of the CAFO Regulations. Manure, litter, and/or process wastewater discharges are prohibited from the production area. There are currently no known existing production area discharge points at these farms.
