**NOTICE OF PUBLIC HEARING.** The Department will conduct a public hearing on a proposed State Plan and amendment to existing Regulation No. 1120 New Source Performance Standards to add a new standard (Section 30) that is applicable to municipal solid waste landfills (MSWLs). On August 29, 2016, the EPA promulgated two regulations applicable to MSWLs. The EPA promulgated 40 CFR Part 60 Subpart XXX, which regulates the emissions from new (i.e., newly constructed, reconstructed, or modified) MSWLs and 40 CFR Part 60 Subpart Cf, which requires States to regulate emissions from existing MSWLs. The purpose of these two federal regulations is to reduce volatile organic compounds (VOCs) and methane emissions from MSWLs. DNREC is proposing to incorporate the federal new MSWL requirements in Subpart XXX by reference as Section 30 of Regulation No. 1120. To satisfy the existing MSWL requirements of Subpart Cf, the applicability of Section 30 will be expanded to include both existing and new MSWLs. Once finalized, Section 30 and the State Plan will be submitted to the EPA for approval. There are three MSWLs in Delaware; all are operated by the Delaware Solid Waste Authority and will be subject to the State Plan and amended regulation. The public hearing on this proposed State Plan and amendment of Regulation No. 1120 will be held on April 24 beginning at 6:00PM in the Department's office located at 100 W. Water Street, Suite 6A, Dover, The proposed amendment and the State Plan are available for public review (1) at the Department's office at 715 Grantham Lane in New Castle; (2) at the Department's office at 100 W. **WHS - SITE INVESTIGATION AND RESTORATION SECTION (SIRS)** is responsible for the identification, evaluation, and remediation of sites in Delaware that have had past releases of hazardous substances. The section manages the contaminated sites under three major programs in accordance with the Hazardous Substance Cleanup Act (HSCA). The three programs are the **Brownfields Development Program, the Voluntary Cleanup Program (VCP), and the HSCA Enforcement Program** (for sites requiring enforcement action).

**The Brownfields Development Program** encourages the cleanup and redevelopment of vacant, abandoned, or underutilized properties, which may be contaminated. A party seeking to develop such a property negotiates with SIRS for a **Brownfields Development Agreement (BDA)** to perform an investigation and, if necessary, a remedial action or remedy, for the purpose of addressing the risks posed by past releases of hazardous substances at these sites. However, a BDA is only available to parties that are not current site owners. The **Voluntary Cleanup Program (VCP) Agreement** is available to site owners who want to clean up their sites and are already liable as a potentially responsible party for the site.

**FINAL PLAN OF REMEDIAL ACTION FOR THE 4928 & 4929 North DuPont Highway Dover, Delaware Site (DE-1627)**

The Department has adopted a plan regarding the clean-up of 4928 & 4929 North DuPont Highway site located in Dover. The Site was historically used for agricultural and commercial/industrial purposes. Most recently, the Site operated as an automotive repair shop and salvage yard. The Site requires capping with either hardscaping (concrete or asphalt) or a two-foot cap of DNREC approved clean fill, the filing of an environmental covenant limiting interference with the remedy and groundwater withdrawal, and the design and the installation of a soil gas vapor mitigation system in the areas of occupied space within each of the proposed future buildings. DNREC issued public notice of the Proposed Plan on February 26. There were no comments or questions from the public regarding the Proposed Plan. These inspections take place at different types of facilities including gas stations, facilities that have large tank systems, and industrial or manufacturing sites located in Delaware.
