**LEGAL NOTICE**

**PUBLIC HEARING**

The Department of Natural Resources and Environmental Control (DNREC), Division of Air Quality, will conduct a public hearing on proposed amendments to **Section 2.0 of 7 DE Admin Code 1142, "Control of NO<sub>x</sub> Emissions from Industrial Boilers and Process Heaters at Petroleum Refineries."** These amendments are based on a May 31, 2010 agreement between DNREC and the Delaware City Refining Company, LLC ("DCRC") which states that DNREC will propose to revise Section 2.0 of 7 DE Admin Code 1142 to provide for compliance with a facility-wide NO<sub>x</sub> emission cap as an alternative to the existing unit specific NO<sub>x</sub> emission limitations.

In addition, DNREC will propose a document for submittal to the Environmental Protection Agency (EPA) as a **State Implementation Plan (SIP) revision**. This document, **"Demonstration that Amendments to Section 2.0 of 7 DE Admin Code 1142, Control of NO<sub>x</sub> Emissions from Industrial Boilers and Process Heaters at Petroleum Refineries, Do not Interfere with Any Applicable Requirement of the Clean Air Act (CAA)"** demonstrates that these proposed amendments to 7 DE Admin Code 1142 will not interfere with attainment or maintenance of any National Ambient Air Quality Standard (NAAQS), or any other applicable requirement of the CAA.

**The public hearing on this proposed amendments to 7 DE Admin Code 1142, and the associated SIP revision, will be held** February 1, 2011, beginning at 6:00 p.m., in DNREC's R&R Bldg. Auditorium, 89 Kings Highway, Dover, Delaware 19901.
