The Department of Natural Resources and Environmental Control (DNREC), Division of Waste & Hazardous Substances will conduct a virtual public hearing (Docket #2020-R-WH-0005) on the proposed revisions to 7 DE Admin. Code 1351 "Underground Storage Tank Systems."

The objectives of revising 7 DE Admin. Code 1351 are to clarify existing regulatory language, add clarifying language, include a federally-mandated compliance deadline, and to correct typographical and grammatical errors.
